Background

On March 27, 2020, Congress passed, and the President signed into law the Coronavirus Aid, Relief, and Economic Security (CARES) Act. The CARES Act provides \$30.75 billion nationwide in an Education Stabilization Fund to prevent, prepare for and respond to the coronavirus, of which:

- \$13.2 billion is for the Elementary and Secondary School Emergency Relief Fund (ESSER) to support the ability of local educational agencies (LEAs), including charter schools that are LEAs, with emergency relief funds to address the impact that Novel Coronavirus Disease 2019 (COVID-19) has had, and continues to have, on elementary and secondary schools across the nation; and
- \$2.95 billion is for the Governor's Emergency Education Relief Fund (GEER) which provides grants to Governors for the purpose of providing educational agencies with emergency assistance to address the impact of COVID-19.

Governor's Emergency Education Relief Fund (GEER)

New York State has been allocated \$164.2 million under the Governor's Emergency Education Relief Fund (GEER). The entirety of New York State's GEER funds were programmed in the 2020-21 enacted New York State budget through the application of a "pandemic adjustment" to partially offset the state share of state aid to school districts. Pursuant to the direction of the Governor's Office and the Division of the Budget, GEER funding is being allocated to the State's 673 major school districts. GEER funds are not being allocated to LEAs that are charter schools, Special Act School Districts, or school districts employing fewer than eight teachers. These funds will be allocated to eligible school districts using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent fiscal year (2019-20).

Elementary and Secondary School Emergency Relief Fund (ESSER)

New York State has been allocated \$1.037 billion under the Elementary and Secondary School Emergency Relief Fund (ESSER). ESSER funds to school districts were programmed in the 2020-21 enacted New York State budget through the application of a "pandemic adjustment" to partially offset the state share of state aid to school districts. ESSER funding is being allocated all LEAs, including charter schools and Special Act School Districts, that received 2019-20 Title I, Part A subgrants. Pursuant to the terms of the CARES Act, Local Educational Agency (LEA) allocations were calculated using the relative shares of grants awarded under Title I, Part A of the Elementary and Secondary Education Act (ESEA) for the most recent fiscal year (2019-20).

Upon the COVID-19 closure in the Spring of 2020 and by completing the Educational Technology Survey in June 2020, the Liberty Central School District identified technological and remote learning needs. Knowing that more students will be using their Chromebook devices while in school and will continue to use their Chromebook devices while out of school, the district identified our most important needs are our technology needs. After gathering data from surveys and after reaching out to our school community, we identified 79 students who did not have access to the internet. Moreover, the district identified that implementing our hybrid learning will create different needs.

To fulfill the educational inequities, the district decided to update our WAP and network storage to expand the connectivity for our students. Also, there were cameras supplied for each classroom so we could implement our hybrid/virtual learning models. In addition, the district acquired replacement screens to repair our 1:1 Chromebook devices more efficiently. In addition, the district acquired additional cables to improve one to one device usage in our classrooms. As the district is implementing these digital items, we will continue to assess our students' academic growth using our already implemented universal benchmark platform for grades PreK to 8 (Renaissance). Our high school will create mid-year assessments and common formative assessments to evaluate the students' learning gaps. Our PLC and Student Support teams will continuously evaluate our students' progress and coordinate additional supports for our struggling learners.
